Arkansas APCD Data File Types

- Arkansas APCD Data Request Data File Types
 - Claims-Based Data Files
 - Fully insured commercial carriers
 - Self-insured entities receiving public funds
 - Arkansas Medicaid (benefit payer)
 - Arkansas Medicare* (benefit payer)
 - Non-Claims-Based Data File Linkages
 - Arkansas Department of Health (ADH) Vital Statistics Data
 - ADH Hospital Discharge and Emergency Department Data for the uninsured
 - ADH Arkansas Cancer Registry Data
 - ADH Medical Marijuana Cardholder Data
 - Arkansas Workers Compensation Data
- Data Request Models
 - Individual Data Package: Data purchased for one-time use on a single project
 - Subscription Package: Data purchased can be used for multiple projects

Claims-Based Data

- Contains fixed set of data elements
- Can include creation of derived or aggregated fields
 - e.g., length of stay, total cost of care, etc.
- Allows linking across data file types
 - 2 or more claims-based data file types within an entity using Enrollee ID
 - e.g., pulling all medical claims for enrollees in qualified health plans
 - APCD Unique ID linkages across claims-based data entities
 - APCD Unique ID linkages across claims-based data and non-claims-based data
 - Application of collision probability model to enhance APCD Unique ID linkages based on project requirements
- May include non-standard programming or analytic requirements not identified above
- May include non-standard date range selection

Non-Claims-Based Data

- Contains fixed set of data elements
- Cannot be provided without linkage to claims-based data
- Allows linking across data file types
 - APCD Unique ID linkages across non-claims-based data types,
 - e.g. birth certificate data, hospital discharge data
 - APCD Unique ID linkages across claims-based and non-claims based data
- May include non-standard programming or analytic requirements not identified above
- May include non-standard date range selection

Individual Data Packages

- Standard Data Pull
 - Allows selection of specific data elements
 - Includes data segmented by calendar year, no other constraints included
 - Priced based on calendar year*
- Selected Subset Criteria Data Pull
 - Allows selection of specific data elements
 - Allows constraints on requested data elements for selection or omission of data rows based on data element values
 - Includes data segmented by calendar year
 - Priced based on calendar year*



**Example: If the selected year is 2013, the data set would contain data between Jan. 1, 2013 and Dec. 31, 2013.*

Individual Data Packages

- Custom Data Pull
 - May include creation of derived or aggregated fields
 - e.g. length of stay, total cost of care, etc.
 - Allows linking across data file types
 - 2 or more claims-based data file types within an entity using Enrollee ID
 - e.g., pulling all medical claims for enrollees in qualified health plans
 - APCD Unique ID linkages across claims-based data entities
 - APCD Unique ID linkages across claims-based data and non-claims-based data
 - Application of collision probability model to enhance APCD Unique ID linkages based on project requirements
 - Allows for the creation of targeted analytic universes
 - May include non-standard programming or analytic requirements not identified above
 - Requires custom pricing model

Subscription Data Package

- Contains fixed set of data elements for claims-based data and non-claims-based data
- Can include creation of derived or aggregated fields
 - e.g., length of stay, total cost of care, etc.
- Allows linking across data file types
 - 2 or more claims-based data file types within an entity using Enrollee ID
 - e.g., pulling all medical claims for enrollees in qualified health plans
 - APCD Unique ID linkages across claims-based data entities
 - APCD Unique ID linkages across claims-based data and non-claims-based data
 - Application of collision probability model to enhance APCD Unique ID linkages based on project requirements
- Data use with non-claims-based data must include linkage with claims-based data
- May include non-standard programming or analytic requirements not identified above
- May include non-standard date range selection
- Requires subscription pricing model

- Claims-Based data includes private carrier data, Arkansas Medicaid data, and Arkansas Medicare Data.

- "Year" is based on calendar year. For example, single year 2013 would contain data between Jan. 1, 2013 and Dec. 31, 2013.

**Arkansas APCD Provider data is delivered in a single file with all years of data. When purchasing this file, data requesters will be charged for the entire file, not each year separately.*

Non-Claims-Based Data Linkages

Associating claims-based and non-claims-based data based on APCD Unique ID and gender (at minimum)

Price

\$110 per hour per file type per year;
10-hour minimum per year selected

The number of hours required is dependent upon the amount of claims-based data being purchased and additional match fields identified.

To qualify for a discount, the data requester must include a discount justification statement in the data request packet. Students must include a statement from their academic sponsor confirming student status and academic institution.

Purchasing Guidance

- Use Arkansas APCD Request Price Estimator tool to approximate what standard and standard subset requests might cost
 - Custom projects, collision probability model will require separate pricing
- The Arkansas APCD technical support team is available to work with data requesters on data selection and pricing options to ensure the best price possible
- Depending on requirements, custom projects and collision probability model can be requested with standard and standard subset data requests
- Final pricing will be included in the data use agreement executed between the data requester and the Arkansas Insurance Department

Purchasing Guidance

- All data requests come with 2 hours of technical support, tracked in 15-minute increments (wait time not included)
 - Additional technical support may be purchased
- Non-claims-based data sets cannot be provided in isolation; they can only be provided through linkage to claims-based data
- Data is sold by the calendar year, unless otherwise specified
 - Data segmentation or exclusion will incur additional charges
 - e.g., demographics, disease conditions, etc.
- Standard Packages and Selective Subset Criteria Packages may be mixed in a data request
 - e.g., standard data sets may be used for medical claims, but a date range is required for members; this requires a Standard Package for medical claims and Selective Subset Criteria Package for members
- Claims-based data sets will contain the current version of each claim received to date

Purchasing Guidance

- Plan/enrollment data contain records representing all activities for a member within a plan
 - Data requests will include multiple records per enrollee.
- Data requesters can select from the available fields outlined in the Arkansas APCD data request element list
- Derived fields — e.g., ZIP3 (the first 3 digits of the 5-digit USPS ZIP code) and Age — are provided in compliance with Arkansas APCD data security protocols
 - 5-digit USPS ZIP code and/or date of birth may be available with additional justification and approvals
- Datasets not described herein are considered custom and will be charged using the Custom Data Pull model

Purchasing Guidance

- Pursuant to Act 1233 of 2015, requested data cannot be used to
 - Support purely commercial initiatives such as resale
 - Disclose trade secrets of submitting entities
 - Re-identify or attempt to re-identify an individual who is the subject of any submitted data without obtaining the individual's consent consistent with the terms of the data use agreement
 - Create or augment data contained in a national claims database
