Use the member numbers (ME107) from this grouping to find claims. Include additional fields to satisfy the grouping: When MC001 = 95448B and MC004, MC005, MC012, MC059 match MC004, MC005, MC012, MC059 when MC001 = 99EBD1. Note, this TPA uses different masking routines for the carrier-specific unique member ID (MC137), therefore it is not possible to find these duplicate claims by member.

Deciphering Service Provider Names

- Provider names (individual and organization) for medical services are captured in MC030 and are related to the Service Provider NPI in MC026
- Sometimes the service provider name information does not seem logical, complete or correct
- Data users can utilize this methodology to help determine the validity of the service provider data





Deciphering Service Provider Names

- To obtain additional organization information related to the service NPI that is not included in the medical claims record, reference the NPPES NPI data on the CMS website
- Download as many of the tables as you wish but specifically include the table called Other Name Reference File (this file name may vary slightly)
- Select the record(s) with the matching NPI(s) to profile other related organization names


HTI Arkansas APCD Population Distribution

- The Arkansas APCD contains health insurance claims from fully insured plans, Arkansas Medicaid, Arkansas Medicare, and Arkansas Employee Benefits Division for state and public school employees
- It does not contain health insurance claims for private, selfinsured plans, small plans with fewer than 2,000 members, and the uninsured (leaving a gap in population numbers)
- ACHI has created a statewide and county populations distribution table that provides estimated rates of coverage based on the APCD and other external data sources







